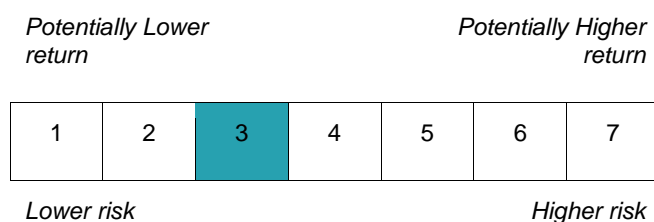
### Description of this fund

A200 invests in assets seeking to minimise short term movements up and down in value, preserve purchasing power of capital and provide an expected return higher than bank term deposits.

### What are the risks of investing?

Risk indicator for A200

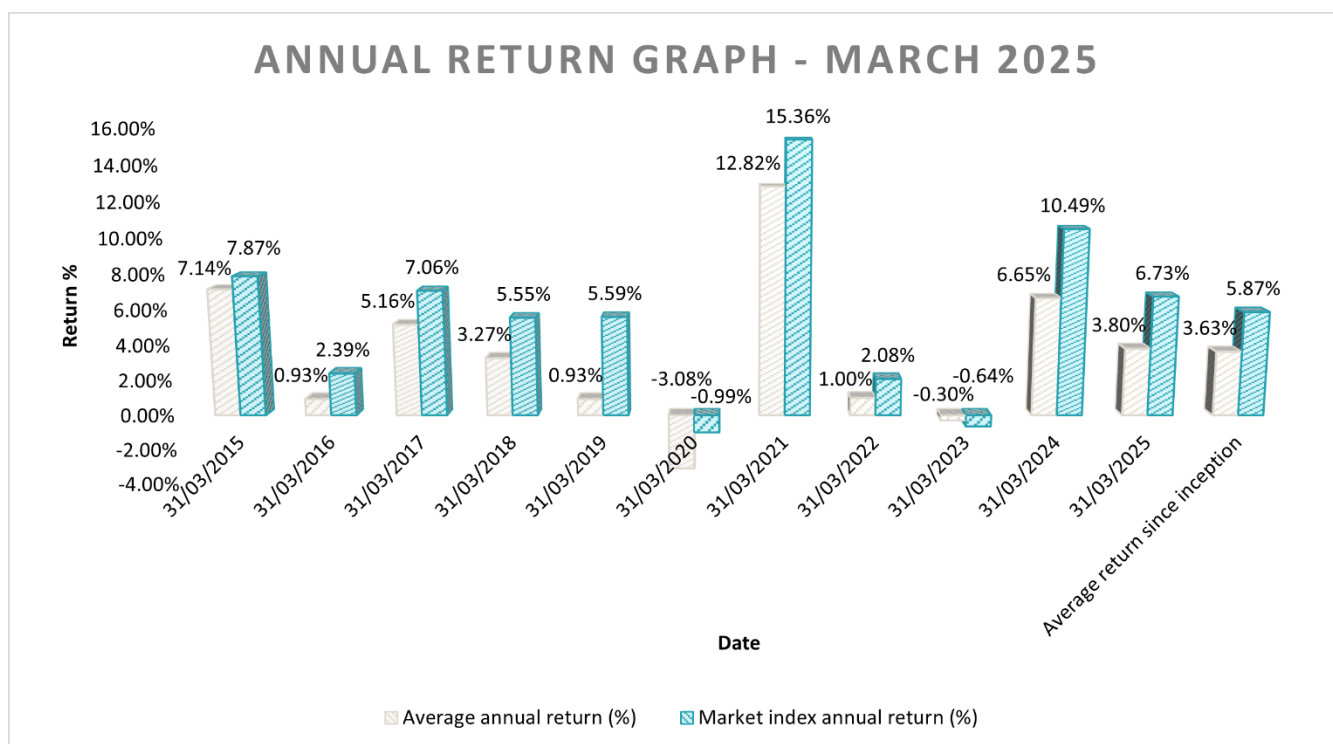

Small differences in fees and charges can have a big impact on your investment over the long term.

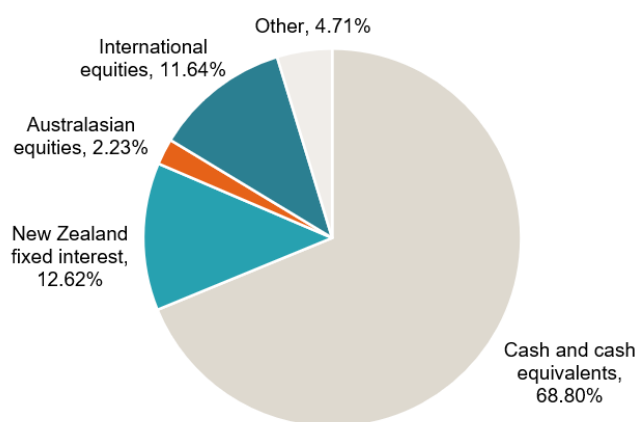
## Example of how this applies to an investor

Jane had \$100,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$5,010.00 that is 5.01% of her initial \$100,000. Jane also paid \$0.00 in other charges. This gives Jane a total return after tax of \$3,800.00 for the year.

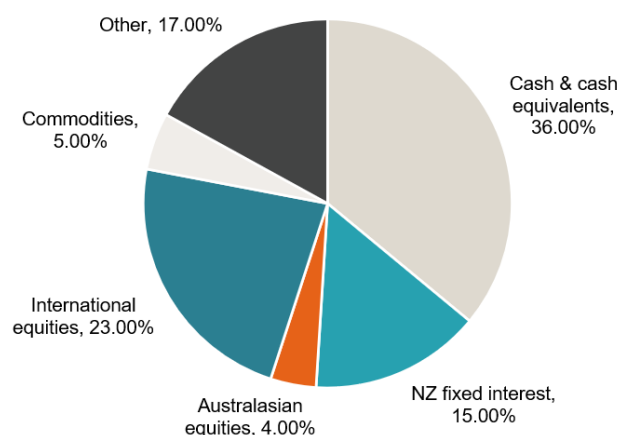
## What does the fund invest in?
